- Affiliated to the University of Kalyani, Krishnagar Government College (KGC) offers 15 Undergraduate Programmes and Four Post Graduate Programmes, following the Choice Based Credit System (CBCS) and implemented NEP 2020 for the 2023-24 academic batch onwards.
- The College prepares the academic calendar based upon the affiliating university calendar and each department monitors academic activities. In addition to routine activities, project work, field-work, excursion and study tours organized by some departments help students understand the concepts better and enrich their academic skills.
- Apart from university-prescribed syllabi, some departments have conducted **Add-On** courses to supplement students' skills and enhance employability.
- The issues like gender equality, women empowerment, environmental sustainability, human values, professional ethics, etc. have been integrated in teaching to enhance awareness and make students responsible citizens.
- Feedbacks from the students on academic and overall services taken periodically.
- Students are encouraged to appear in national-level competitive examinations like JAM, NET, SET, GATE, CUET (PG), etc.
- Calendar of events to include academic, extension, co-curricular and extra- curricular activities. Emphasis could be given on courses on entrepreneurship and language proficiency.

- The college offers both UG and PG programs with experiential and interactive learning opportunities. Every department conducts continuous internal assessments, seminars and other events in accordance with the academic schedule. Teachers also offer proper guidance and counsel students to overcome the learning challenges.
- Cross-cutting issues like Gender sensitivity, environmental awareness and IKS are introduced through add-on courses.
- The college prepares its students **for the semester-end examinations**. Class-tests, quizzes, students' seminars, etc. are in practice for internal assessment. Complaints from students about their internal assessments or semester-end examinations are addressed, whenever required.
- Annual Student Satisfaction Surveys are conducted and gaps/lacunae/grievances are identified and fulfilled in the future plan of action by IQAC as far as possible.
- Faculty may be provided with workshops on Outcomes Based Education and encouraged to assess attainment of Program and course outcomes. Relevant FDPs may be organised to enrich academic delivery.
- Students to be encouraged to involve in research based learning and live projects.
- More than 90% faculty members have Doctoral (Ph D) qualification

- IQAC of the College in collaboration with the Patent Office, Kolkata organized one day awareness programme on IPR under NIPAM 2.0. Department of Botany organised a workshop on Mushroom Cultivation providing hands-on training and financial viability.
- NSS unit of the college has conducted societal activities such as blood-group determination, blooddonation, health check-up, campus cleaning, plantation campaign, nutritional diet, thalassemia, riverpreservation, dengue-prevention, cleanliness and hygiene, plastic-prevention, cyber-crime, regular deworming of children, etc., in the near by communities.

- College celebrates days of national importance, commemorative days and festivals to nurture ethical values, cultural awareness, national spirit and integration and imbibe the social attitude among the students.
- Research culture to be fostered to involve all faculty members in research and consultancy initiatives. Faculty may submit their research work for Patent and Copy write.

- College has a built-up area covering 6.88% of the total land of 36.06 acres and provides scope for further infrastructure development.
- The College has 40 class rooms including four seminar rooms in which 3 classrooms with fixed overhead projectors smooth conduct of teaching-learning process. **The Main building** accommodates the Principal's office, the IQAC room, Girls' common room, NCC unit and some classrooms.
- All departments have departmental library for immediate access.
- The Central Library possessing additional books and some e-journals, rare-books section. However, there is a need to encourage students to utilise the library resources.
- Besides academic resources, the college provides various facilities to students. There are playgrounds for outdoor sport activities, a gymnasium, students' canteen, two boys' Hostels and filtered drinking water facility available on the campus. Girl's hostel building is available, however, it should be made functional. Hygienic Washroom facilities to be provided, especially for girls.
- Wi-Fi internet connectivity is available in select places and to be provided throughout the campus. Some classrooms may be equipped with smart boards to enhance students involvement in learning.

- College offers valuable services and strategies to help students succeed through their academic journey, ensuring smooth progress. Students receive education at a very affordable fee structure and more than 50% of students received various scholarships during 2018 – 2023
- The college offers add-on / value added courses to improve students' capabilities, knowledge, and competencies for competitive examinations. Faculty members constantly motivate and guide students to attain academic and professional careers.
- Academic progression of students to higher studies partially documented and some students have secured admission in premier HEIs like IIT, Central Universities etc. and qualified competitive Examinations like JAM, NET, SET, GATE, GRE, TOEFL etc. Students are guided for some job opportunities in both public and private sector.
- Some students secured academic rank in university examinations. College supports and encourages students to actively engage in co-curricular and extra-curricular activities.
- Internal Complaints Committee, Anti-Ragging Committee, and Grievance-redressal cell ensure staff and students well-being. To prevent ragging, the college takes self-declaration from students during admission. Grievance submission form is made available on the college website (online) and through grievance submission box (offline) for prompt action.

• Registered Alumni Association of the college exists since 2008, however, college should take initiatives to involve alumni to contribute positively to the upliftment of the infrastructure and academic deliverables.

- College has a legacy of inculcating social values, responsibility, and environmental consciousness in students. The college fosters a vision of gender equity and inclusiveness through teaching-learning. Hassle-free disbursement of different government scholarships like Kanyashree Prakalpa and PG Indira Gandhi Scholarship for single girl child, reinforce the positive impact on female education.
- Implementation of green initiative by installing 10 kW solar panel, reduces institution's carbonfootprint, is an innovative and effective management strategy of the college.
- To address the paucity of pollution-monitoring units in the district, College has installed the Air quality monitoring system through West Bengal Pollution Control Board, serving as an educational tool and aiding environmental measures.
- College celebrates different commemorative days namely, Independence Day, Republic Day, International Mother Language Day, International Women's Day, World Environment Day etc.
- College conducts green and energy audits, and use of single use plastic (SUP) is discouraged within campus.

- The college employs a waste-disposal system for segregation and management of dry and wet waste in separate colour-coded dustbins.
- To make the campus disabled barrier free provision of ramps are created in buildings for divyangjan students.
- Reservation rules of Central and State Governments are strictly followed during admission process, ensuring an inclusive environment for socio-economically backward students.
- Students are sensitized about constitutional rights and responsibility by celebration of Constitution Day, National voters day, etc.
- Students are directed to abide by the code of conduct as stated in the admission prospectus.
- Best Practices of the college include Community Services by the students and teachers, and Green Initiatives initiated.

Overall Analysis

Strength:

- As a 179-year-old institution, College is catering to aspirations of thousands of students from diverse backgrounds and shaping their future with good education since 1845.
- A vast campus provides a tranquil atmosphere conducive to learning, with scope for further expansion of physical structure.
- The campus is protected by well-bounded walls, and students safety is monitored and ensured through CCTV cameras in some place.
- Research publications totaling 172 during the assessment period (2018-2023) in UGC CARE, SCOPUS and other peer-reviewed journals.
- A new program in Statistics initiated during the academic year 2023-2024 shows the commitment of the institution towrds the changing needs of the market.
- As a good initiative embracing renewable energy by installing 10 kWp solar panels shows the commitment of the institution in minimizing the carbon foot print.

Weaknesses:

- Inadequate or paucity of funds/grants is a major stumbling block for the implementation of number of developmental and extension activities.
- The acute shortage of teaching and non-teaching staff strength compared to sanctioned strength has affect on the quality of teaching and efficient administration. Further, the lack of adequate number of teaching faculty is a hindrance to the effective implementation of NEP 2020.
- Inadequate classrooms and technology support is hindrance to effective teaching
- College has limited MoUs with eminent academic institutes and industries for internships and collaborative practical training.
- Inadequate instrumentation facilities for Science Programmes.

Opportunities:

- The availability of ample land is an opportunity for physical expansion
- College can explore funding opportunities through schemes such as DST FIST, DBT -Start college

program,, etc.,

- Taking advantage of available land, Creation of Physical Education department certainly kindle the sport interest among students.
- Scope for establishing Research Centres for fostering research.
- Scope for becoming Autonomous institution.

Challenges:

- Adopting to digital and virtual mode of learning due to lack of infrastructural support.
- Due to faculty transfers, departments suffer to sustain new initiatives and continuous progress.
- Delay in implementing decisions lead to deferred progress.

- Ensure uninterrupted electric supply in the campus including students hostels by installing electricity generator with suitable capacity.
